Fairground Vendor Application - Deadline: August 1, 2019

Exhibitors must provide all of their own equipment. Electricity will be available upon request. There is a \$25.00 non-returnable deposit required per space rented. **All deposits are credited in full toward the cost of the space.** Checks should be made out to the St. James Chamber of Commerce and mailed to: St. James Chamber of Commerce, PO Box 358, St. James, MO. 65559. All entries must be received no later than Aug. 1, 2019. The festival will be held rain or shine. There will be no refunds given. Money for change will not be available – Please make sure you have your own change.

Fairground vendors will be accepted in the order that applications and deposits are received. Vendors must be specific in listing the items they will be offering. The St. James Chamber of Commerce holds the right to limit vendors and/or cancel activities. Applicants will be notified of acceptance or rejection as soon as possible after entry deadline. In case of rejection, entry fees will be returned.

This form is for registration for the **FAIRGROUND VENDORS ONLY**. Set up at the Fairground will be assigned on a first come, first serve basis. Set-up begins a noon and must be completed by 4:00 p.m. on Wednesday, September 4, 2019. **There are exclusives which CANNOT be sold on the Fairground. They are: Hamburgers, Cheeseburgers, Turkey Legs, Funnel Cakes, Corn Dogs, Hot Dogs, Cotton Candy, Popcorn, Snow cones and Carmel Apples. Beverages that may not be sold are: Lemon aide, water, and soft drinks (soda). Also, Southern Fun Carnival has the exclusive on all carnival-type games and prizes (e.g. stuffed animals, blow-up toy items, etc.). Vendors will not be permitted to operate games or sell novelty-type merchandise.**
